

ORLANDO'S GOT TALENT 2009

RULES AND REGULATIONS

PROMOTIONAL AUTHORIZATION

By submitting this form, each member of the act grants Orlando's Got Talent the right to utilize the act; and it's member's names, likenesses images, voices, appearances and performances in perpetuity worldwide for advertising, trade or any other lawful promotional purpose whatsoever, in any and all media now known or thereafter developed, without compensation. The act and all it's members also grants Orlando's Got Talent the right to broadcast, market, sell and otherwise distribute the name of the act and/or all of the acts member's names, images, likenesses, voices, appearances and performances, either in whole or in part for commercial, non-commercial television, close-circuit exhibition, home video distribution, internet or any other purpose Orlando's Got Talent, in their sole discretion may determine. The act and all it's members hereby gives all clearance, copyright or otherwise, for the use of the acts and all it's member's names, likenesses, images, voices, appearances and performances embodied in the acts performance /stage presentation.

ASSUMPTION OF RISK

By submitting the entry form, the act and all it's members assumes all risks of property damage or bodily (including death) that might occur during the course of the competition. The act and all of it's members agrees not to bring against and Orlando's Got Talent representative, The Cowboy's Orlando of any of the competitions' sponsors, any claim for property damage or bodily injury (including death) that might occur during the course of the competition.

CHARACTER

The act and all it's members agrees that it may be disqualified from the competition immediately and at any time during the course of the event, if the act or any of it's members commits any act or becomes involved in any situation that would adversely reflect upon the competition, The Cowboy's Orlando or any of the competitions sponsors., or tend to bring it or that party into public dispute. In addition, the officials of Orlando's Got Talent, at their sole discretion, may disqualify an act and all it's members if the act dresses or acts in a manner which adversely reflects on the competition.

ELIGIBILITY

No act may have over seven members. The act and all it's members may not have performed on a record listed in Billboard within the last eighteen months. The act must submit an entry form, a talent DVD and a check in the amount of \$25.00, payable to CIL/Orlando's Got Talent to PO Box 180576, Casselberry, Florida 32718-0576. The act and all it's members must recognize that only 10 per month will be selected to perform at the Cowboy's Orlando each month beginning April 2009 thru September 2009 and that two winners from each of those competitions will be eligible to perform at the final competition in November, 2009. The act and all it's members understands that if any act is removed from the competition at any time, either voluntarily or from being disqualified, they may be notified and asked to replace said act for a chance to compete in the finale. No act nor any of it's members may be a representative of Orlando's Got Talent, an employee of the Cowboy's Orlando or an employee of the event host. They cannot be a friend or relative of any of the judges or of the event host. When the act and all it's members submits the entry form for this competition, they swear they met all of eligibility requires therefore stated on this form.
